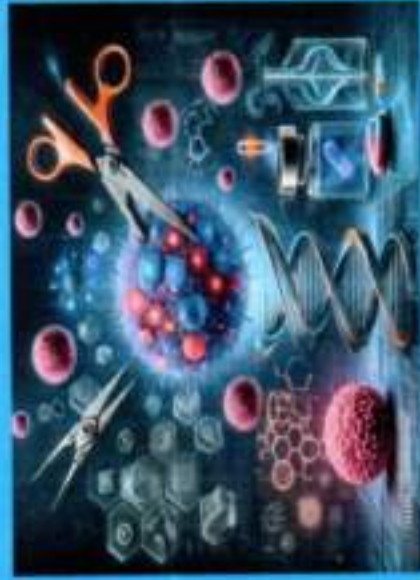

4. There were only a few options of cancer treatment for patients for many decades which include surgery, radiation therapy, and chemotherapy as single treatments or in combination.
5. But recently, many pathways involved in cancer therapy progression and how they can be targeted has improved dramatically, with combinatorial strategies, involving multiple targeted therapies or "traditional" chemotherapeutics, such as the taxanes and platinum compounds, being found to have a synergistic effect.

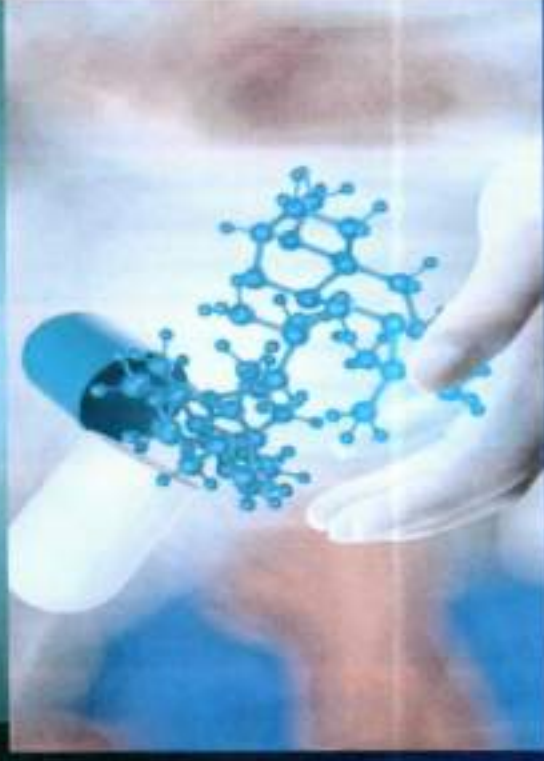
